Information about Nor Lines and Samskip

Samskip is a global logistics company that offers transport services and other related services through land, sea, rail and air with a special focus on cost-effective, sustainable and environmentally friendly transport. With an annual turnover of 630 million euros, Samskip is one of the largest transport companies in Europe with offices in 24 countries in Europe, North and South America, Asia and Australia and with 1,500 employees worldwide.

Samskip's activities in Norway are mainly associated with container shipping in the European shortsea market, to / from ports in Oslofjorden and along the west coast, as well as cold stores and terminal services in Ålesund, through the subsidiary FrigoCare AS. About 30 employees are distributed between offices in Oslo and Ålesund. Through 50% ownership of the company Silver Sea AS, based in Bergen, Samskip is further engaged in shipment of frozen fish to / from Norway and Europe.

Through the acquisition of Nor Lines, Samskip primarily strengthens its presence and network in Norway, as well as strengthening its services for maritime transport through the involvement of side port / freezer vessels and multipurpose vessels in liner shipping along the west coast and northern Norway. National transport and distribution through truck, rail and Hurtigruten contributes significantly to the total offer for Norwegian and international customers.

Overall, Samskip's product and service portfolio in Norway will appear as unique in transport and logistics markets nationally and internationally.


